### **From the Churchwardens**

We are all very sad that Fr Stephen is retiring and he will be greatly missed. We thought it would be helpful to set out what we can about what happens next and how St Botolph's will operate during the vacancy.

To begin with, and most importantly, we would like to thank Fr. Stephen for all that he has done to re-establish St Botolph's as a community and to consolidate our position within the Diocese. This was especially evident in our 700<sup>th</sup> Anniversary celebrations and Bp Stephen's warm words then and, even more so at Fr Stephen's induction as Rector. It is a tribute to both Fr Stephen and to our St Botolph's community that we now have a Rector for the first time in over 30 years.

We have a strong basis from which to approach the challenge of finding a new Rector, something that may take a year or more. During the vacancy we hope to continue as best we can our current pattern and style of worship with the excellent support of Tim and the choir. We are firmly established as the main representative of the BCP tradition in Cambridge and we wish this to continue. We are working with Fr Stephen and Tim Harling, the Dean of Queens', to find someone to provide regular cover for us and we hope that we will also be able to rely upon those who have preached at St Botolph's in recent years.

As to finding our next Rector, a Parish Profile will need to be compiled which sets out information about St Botolph's, our community and worship and, most importantly, a view on the sort of person we are looking for. The PCC is working on this and we look forward to sharing a draft with you and incorporating your views, probably in September.

Following Fr Stephen's retirement in early October, Bp Stephen and the Archdeacon will meet the PCC and Patron to set out their proposals for finding a successor and the terms of the appointment. We are a far more attractive proposition than previously as the position ought now to be for a Rector, but the process of finding and selecting the right person may well take some time. We hope and pray for a good outcome.

In the meantime church life goes on. We are hoping that the porters at Corpus will once again open and close the church for us during the week, but we would like to establish a small rotating team to provide a visible presence in St Botolph's for as much of the week as we can manage. Visitor numbers are starting to increase again and this provides an opportunity to listen and talk to them about what brings them to St Botolph's, as Bp Stephen suggested we should.

If you think you could spare time then please email either of us. If anyone wishes the church to be open at any particular time then do let us know and arrangements can be made.

With all of the wonderful activity and music over our 700<sup>th</sup> Anniversary, we missed the opportunity to write, as our predecessors have traditionally done at this time, to ask for financial support. Many of you have given generously for The Lamb and we are very grateful too to those who have set up standing orders that helped fill the gap in collections and donations during the lockdowns. Although some of our former fundraising activities can now recommence (and we look forward to the book sale on 21 August) we have ground to make up and the annual one-off contributions at St Botolph's-tide used to make a substantial difference. Anything you are able to do will be much appreciated and the website has a facility for this on the Supporting St Botolph's page under the Governance tab.

Lastly, we will be organizing an event after Fr. Stephen's last service on 3 October which traditionally is Harvest Festival. Details will follow.

## **Save the Parish**

A Twitter storm erupted shortly before the meeting of the General Synod in July regarding the proposal, entitled *Myriad*, that was submitted for Synod's support to the planting of 10,000 lay led house churches. This was in addition to the 10,000 church plants already endorsed at a previous meeting.

The proposal received a great deal of attention largely because of very intemperate remarks beforehand by a senior Church Planting official who described clergy, their theological education and church buildings as *limiting factors* to the spread of the Gospel; and the ordinary members of laity, unless engaged in planting initiatives, as *passengers* in the mission process.

Despite the obvious lack of credibility in the target numbers, Synod nevertheless adopted the proposals for lay led planting and house groups, the Archbishop of Canterbury arguing that this was precisely how the Early Church was started. The Church centrally will support such initiatives financially and with other resources.

There was fairly widespread concern in many parishes, including our own, that this would mean the redirection of funds that might otherwise be used to grow and develop parish based ministry.

Fundamentally, it would appear that the Church of England, as we know it, would have no prime place in the new environment, which sees a *mixed ecology* emerging between traditional church and house groups. In fact, it could be argued that as the house groups would be lay led and non-sacramental, there is no actual need for the Church (and its various limiting factors) at all.

An umbrella body, entitled *Save the Parish* is in the course of being set up and I commend the material on its website [www.savetheparish.org](http://www.savetheparish.org) for your further reading and reflection.

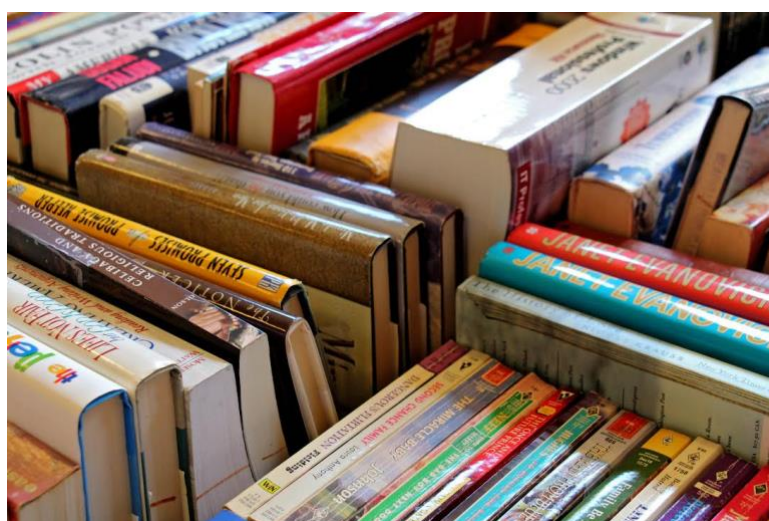
## Confirmation

### **St Botolph's Rectory**



St Botolph's Rectory, an imposing house of fine proportions in Summerfield, was built in 1934 on land bought by way of public subscription from Clare College. It has though not been lived in by the Priest in Charge or Rector for some 35 years.

Instead, it has become the home of the Archdeacon of Cambridge (was Ely) since the earlier times when Archdeacons Long and Walser in the 1970s and 1980s held a combined role of Archdeacon and Rector of St Botolph's.

However, the subsequent Archdeacon Watson held only the Archdeacon role, but still lived in the Rectory. This did not seem to much matter as my predecessor was quite content to continue to live in a property of his own nearby.

On the eve of my Institution and Induction as Rector, I was served, without prior warning or consultation, with a 28 days Notice by the Diocese seeking to transfer the Rectory formally to the Diocesan Board of Finance.

After consulting the PCC, the Norwich firm of Birketts Solicitors, was engaged to challenge the serving of this Notice, which they duly did successfully, on the basis that the Notice was invalid because it was not correctly drawn up legally. Rather than serve the incumbent with the correct Notice, we argued that we should be talking to one another, rather than serving statutory notices.

The Diocese has accepted this approach and at the time of writing, it is hoped to arrange a meeting between the Rector, Churchwardens, Treasurer and Patron with the Diocese in the near future.

The Diocese has made it clear that they wish for the Rectory to remain solely the abode of the Archdeacon. We have been advised legally that we cannot prevent the transfer of the Rectory (because its usage vests it with the Diocese, no matter the source of the initial funding) except by appeal to the Church Commissioners. We shall seek the commitment of the Diocese to provide alternative suitable accommodation for my successor within reasonable walking distance of the parish. If so, then an appeal to the Church Commissioners would have little chance of success. If not, then there will be a basis for an appeal, although the outcome would still be uncertain.

This matter has taken on an added significance with my approaching retirement. It would help enormously with the search for my successor if the role could at least be advertised on a House for Duty basis, rather than on a completely non stipendiary and no benefits basis, which will certainly limit the number of potential candidates.
